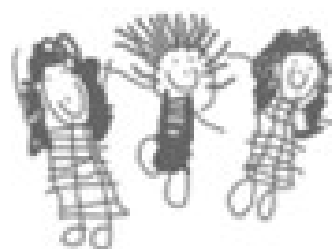


Pupil premium strategy statement
